

Spending Plan: Staffing - Social Emotional

To hire or retain:

- 10+ academic intervention services teachers for reading and math (3 years)
- 3+ reading support teachers (3 years)
- 1 elementary literacy coach (3 years)



Spending Plan: Staffing - Other

To hire or retain:

- 1 CSE and AIS coordinator (1 year)
- 1 occupational therapy teacher (3 years)
- 1 physical therapy teacher (3 years)
- 4 teacher building substitutes (3 years)

Spending Plan: Learning Environment

Spending Plan: Technology

136 Boxlight classroom displays

\$399,318

Replaces aging Smart Boards that are failing districtwide; technology is better visually with built-in features to improve teaching and learning including Smart Notebook and wireless casting capabilities





Spending Plan: HVAC

Replacement of eight (8) rooftop air handlers

\$2,143,149

Replaces 20- to 25-year-old units allowing for filtration and efficiency to increase. As we replace, we will replace with air conditioning



Overall Status Update

- ✓ Currently working with the vendor Trane and the NYSED Office of Facilities Planning to design replacement HVAC systems
- ✓ Have hired or retained all staff per the original plan
- ✓ Purchase orders have been created and sent to vendor to acquire Boxlight interactive displays. We anticipate installation with begin in the upcoming months and continue for the foreseeable future.
- ✓ Currently establishing furniture replacement plan in collaboration with Master Library and staff
