Potential Impacts to Phase 1.1:

Due to the wet spring across the state, the track surfacing contractor is delayed on other projects, which may impact ours. We will have a better idea on the situation in a month.

Phase 1.1 Athletic Field

Work Completed in May


- The turf anchor has been installed around the perimeter of the turf field.
- The concrete stairs and handicap ramp on the High School side of the turf field have been installed.
- The track fabric and stone has been installed.
- The press box and bleachers have been erected.
- Both scoreboard foundations and steel framing are complete.

Projected Work for June

- The Electrical Contractor is pulling all feeder wires to the scoreboards, stadium lighting, and the press box.
- The Site Contractor will be installing the fabric, drainage, and stone on the turf field.
- Aqua drain will be installed around the perimeter of the track.
- Weather permitting, the track will be blacktopped at the end of June/first part of July.

The project is progressing nicely. There have been no unforeseen issues that may impact the schedule.

Potential Impacts to Phase 1.2 and 1.4:

• The Marketplace is saturated with work. As a result, we are anticipating an issue with adequate labor forces.

Phase 1.2 Florence Brasser and 1.4 Paul Road

Work Completed in May

- The Site Contractor has all of the playgrounds erected.
- At Florence Brasser, interior metal framing is complete, and the roof has been installed over the two classroom addition.
- 50% of the electrical and mechanical rough in is complete at Florence Brasser.
- At Paul Road, all metal stud framing is complete in the office suite area, along with all electrical and mechanical rough ins. Drywall has begun.

Projected Work for June

- Edging and wood fibers will be installed around the playgrounds.
- At Florence Brasser, the storefront windows at the two classroom addition will be installed. The electrical and mechanical rough ins will be completed, and drywall work will begin. Asbestos Abatement will begin on June 28th.
- At Paul Road, drywall work and painting will take place at the office suite area.
- The Site Contractor will begin the new parent drop off loop.




